#### NPARC Auction Rules

- 1. Items to be auctioned may be tendered in one of two ways:
  - A. Donation of item to the NPARC.
  - B. Member maintains ownership until item is sold.
- 2. Donated items and auction proceeds therefrom become the property of the NPARC at the time of the sale. Anyone may donate items to NPARC for auction.
- 3. Proceeds from items tendered for auction, which have not been donated, will be given to the owner when the auction is over, less a 10% fee or \$10.00, whichever is the lowest amount. Only NPARC members may tender items for such sale.
- 4. A minimum price should be set by owners. The Auctioneer may ask the owner to reduce his minimum if there are no offers at the minimum price. The owner may withdraw the item if he or she wishes.
- 5. All items, whether donated or tendered for sale, must be marked with the identification of the donor/seller.
- 6. The Auctioneer is authorized to: a) bid for his own account; b) combine donated tots; c) ask for a reduced minimum sale price; d) use diverse techniques in obtaining bids; e) withdraw or cancel a price progression or sale if some inequity is found to exist.
- 7. Successful bidders will consummate their purchases with the cashier immediately.
- 8. All unsold items, whether donated or tendered for auction, must be removed from the premises by the donor/seller if the item is not sold.
