Don't forget that the NNJ VE Board is alive and well and has sessions the second Saturday of each month. Exams are conducted at Union County College in Cranford, NJ. FCC form 610 applications with copy of existing amateur license and \$4.25 check payable to "ARRL VEC" should be received at least 30 days prior to exam date. # A.R.R.L. UPDATE - LATEST INFORMATION FROM THE LEAGUE

In an effort to provide even more service to ARRL affiliated clubs, the Club Services Department has been formed at ARRL Headquarters in Newington. Its mission is to work more closely with ARRL's affiliated clubs, emphasizing their role as an effective grassroots force in the areas of amateur radio instruction, new-ham recruitment, and public information dissemination. The department will be responsible for the Affiliated Club Program, the Audio/Visual area, grassroots new-ham Training Program, and the local Pub-

lic Information program. If you have any questions about the new department drop a line to department head Curt Holsopple, K9CH.

The ARRL Ad-Hoc Committee On Digital Communications has worked up a list of features needed in VHF/UHF digital radios and will approach VHF/UHF experimenters for some help. Progress has been made on networking protocols, but there is still much work ahead. Additional information can be found in the report on the Fifth ARRL Amateur Radio Computer Networking Conference from League HQ.

Electronics, communications, and aerospace companies often produce in-house training tapes. Many of these are high-quality productions with content of interest to hams. If you, or your company, use such tapes, why not help everyone, and update the Leagues training library at the same time by getting the OK to donate a copy of the tapes to the League so that the Leagues A/V service may duplicate and distribute them nationally.

Have you upgraded your license recently? If you did, the Gettysburg office of the FCC says that it will take 16 working days, about three weeks in "real time", to process your new license. Add an additional week or two for processing by the Volunteer Examination Coordinator, and you have a realistic time frame for expecting your ticket.

If you have upgraded, and are thinking of changing your callsign at the same time, remember that licensees who upgrade are eligible to request a callsign change at the time of that upgrade. Your callsign will not be changed unless a specific request is made at that time. Item 2E, "change of callsign", should be checked. After the request is made you will be issued a new callsign by the Commission. You are not allowed to request a specific callsign. You always have the option to retain your current callsign.

Effective January 1, 1986, only the June 1984 and later editions of FCC Form 610 may be used to obtain an amateur license. Applying on earlier editions of the form after January 1 will delay issuance of your license. FCC says that your application will be returned without action requiring you to refile on a current form.

## COMPUTER OPERATED AMATEUR RADIO STATION

Larry, "Tree" Tyree, N6TR, of Beaverton, Oregon, used what may have been the first completely automated computer operated amateur radio station during Field Day this year.

Note made a number of CW contacts using a 780-based computer and some experimental software which ran a TS-430 tranceiver using battery power without the need for any human assistance. The software tunes the receiver, locates the station to call (it only answers CQs so far), completes that QSO, prints out a record of the contact, and continues to scan for a new QSO. Note notes that there is still a long way to go before it can come close to matching a human operator!

# CABLE TVI, OR NOT TVI. THAT IS THE QUESTION.

Last month I was providing a talk-in for our speaker, Steve Mendelsohn, WA2DHF, from the home QTH. I then went mobile to rendezvous with Steve at one of the Bell Labs entrances. Curiously, a Suburban Cable TV truck with bubble green machine lights flashing flagged me down as I pulled into the entrance claiming that I was interfering with a cable-ready TV set on Berkshire Drive, Berkeley Heights, operating on cable channel 18. They had picked up my transmissions on a scanner. (By the way, in New Jersey it is illegal to carry an operable scanner in a car or TV cable truck without a permit). There was a "I to I correlation between my transmissions and the interference." This interference had persisted for several weeks, and several customers on that street had complained to the company. The FCC was also about to be notified as soon as the customer could locate a big enough antenna tower to pin the blame on. (Mine qualifies easily).

It turns out that cable channel 18 operates on our 2-meter Ham band, and as some of our own members have discovered, unless both the cable system and TV set are properly shielded against off-the-air pickup, they will most definately be subject to interference from any properly operating 2-meter rig in the immediate vicinity. I was interfering with a set well over 1/2 mile away; strange even with the worst of TV's.

A test was arranged with the cable company, and the New Providence Club was ready. When the cable company arrived at my house their representative was somewhat shocked to be greeted by a squadron with mobile and handheld 2-meter units, namely, John Sheetz K2AGI, Floyd Harvey KA2DDG, Bay Rowan W2GKF, Rick Anderson WB2QQQ, Tom Brown KA2UGQ, Harry Kundrat W2YEZ, and Bob Latter, W2YFM. The company representative was reluctant to allow the NPARC members to participate until it was made quite clear to him that without the club members I would cancel the test, since I was reluctant to be "nailed" as the sole cause of a problem brought about by their insistance on operating on our 144-148 MHz band. At that point the mobile units convoyed to Berkshire Drive, while W2YFM offered his support at the W2EMÉ base station. Fortunately, no W2EME transmission resulted in interference. Only when a 25-watt mobile unit was stationed directly in front of the customers house did any problem result. The cable company theorized that when they tightened the coax connections on their customer's set the problem was ameliorated. Only the cable company knows about the alleged "complaints" from all the other Berkshire Drive customers.

After the tests were concluded, some of the participants returned to W2EME's for cider, cookies and a discussion of the test result. Thanks to the 7 members who responded, it turned out to be quite a non-event.

#### XYL CORNER - RECIPE OF THE MONTH

The following is from Scotty Snyder (XYL of Bud KB2GN) and was one of the desserts at the NPARC Pool Party at Al Hirsch's (K2SKV) house:

#### Scotch Short Bread

4 1/2 cups flour 1 lb butter

1 cup sugar

1 teaspoon vanilla

2 teaspoons almond flavor

Cream the butter. Add sugar. Cream together. Add flour slowly. Add vanilla and almond extracts. Knead, adding small amounts of flour as necessary. Knead well. Divide into three. Pat dough into three pie pans. Wave and prick with fork. Bake at 325 degrees until golden, about 40 minutes. Cut into wedges while hot. Makes about six small wedges per pan.


